AOA Selects Next Executive Director

Maintenance of Licensure Resolution Referred to Bureau of State Government Affairs

The New Jersey Association of Osteopathic Physicians and Surgeons submitted Resolution H-623, for consideration by the AOA Board of Trustees and House of Delegates during their 2013 Annual Business Meeting. This resolution stated that maintenance of licensure is burdensome and duplicative of ongoing work performed by osteopathic physicians and called for the AOA to oppose all maintenance of licensure efforts by state licensing boards. The resolution was discussed by the House of Delegates and referred to the BSGA for further consideration. The BSGA will examine the issue over the coming year, and report back to the AOA House of Delegates in 2014. Jeremy Edmonds, DO, AAOE representative to the BSGA, is likely to be heavily involved in this process and will provide the perspective of the AAOE.
