## 2010 Summit Recap

The AAOE held its annual Summit on January 16 - 17, 2010, in San Antonio, TX at the Water Mark Hotel and Spa on the historic river walk. The meeting was presided over by the AAOE President Jim Andriole, DO. The meeting was well attended and the agenda topics proved to be informative, stimulating, and generated much discussion.

Some highlights of the summit agenda include:

We first heard from AOA Executive Director John Crosby, JD, who gave the osteopathic examiners an update on the AOA's involvement with the FSMB and international efforts of licensure.

The AAOE heard an informative update from NBOME President John Gimpel, DO, MEd, and Board Chair John Thornburg, DO, PhD. AOA Trustee Boyd Buser, DO, gave an update on international osteopathic medicine.

Richard Snow, DO, MPH, along with Sharon McGill, MPH, presented the AOA's Clinical Assessment Program (CAP).

Vincent DiCianni, JD, President of Affiliated Monitors, spoke on the role of monitors with state licensing boards as well as the success of rehabilitation with such monitors.

The AAOE heard a presentation on medical spas and cosmetic surgery from Michael Will, MD, and Peter Canalia, JD, of the American Board of Cosmetic Surgery.

David Gensure from Nova Southeastern University COM presented on ethics, professionalism and clear communications.

AAOE members shared with the group the 'hot topics' in their state. We also heard an update from Geri O'Shea, DO, President of the Osteopathic Medical Board of California (OMBC), regarding the inclusion of naturopaths on the OMBC.

During the AAOE business meeting, the bylaws were discussed, reviewed, and amended by unanimous vote. Other business matters were discussed to enhance the AAOE efforts. The AAOE presented the A. Archie Feinstein Award to Martin Crane, MD, Chair of the FSMB.
